## **Terms and conditions**

### §1 Definition of the service

Flexible office space in an open coworking space with clean desk policy with a coworking weekly ticket and a coworking membership Flex. Fixed office space in the coworking space without a clean desk policy with the coworking membership Fix. Included are: Desk, office chair, electricity, heating, internet, coffee, water and tea, informal reception for clients and guests, printing & scanning at cost price

#### §2 Contract period and termination

The lease is for an indefinite period of time and can be terminated by either party in writing (letter, e-mail) 10 days before the end of the subscription period. The minimum contract period is one month for a coworking weekly ticket and a coworking membership Flex. The term is three months for the coworking membership Fix. The Coworking Nürnberg GmbH can terminate the contract without notice if the Service User is more than four weeks in arrears with the rent, if one of these contractual conditions is not complied with, or if it is determined that the Service User is conducting unfair business.

#### §3 Rent and payment

The monthly rent for the coworking weekly ticket is 89 € incl. VAT, for the coworking membership Flex 179 € incl. VAT and for the coworking membership Fix 319 € incl. VAT and will be invoiced monthly. The rent is due in advance and is collected by SEPA direct debit mandate.

### §4 Contract changes/salvatory clause

The assignment of rights from this contract to third parties is not permitted to the Service User without the consent of Coworking Nürnberg GmbH. Changes or additions must be made in writing; there are no subsidiary agreements. Should individual provisions of this contract be invalid, the rest of the contract shall nevertheless remain valid. The place of performance and jurisdiction is Nuremberg.
